Ms. Fogleman: What follows is for the attention of Colonel Edmonson and Lt. Col. Dupuy. Gentlemen: The subornation of PERJURY by "Special Counsel" McGaha, and his participation in a conspiracy to commit same, obstruction of justice (and conspiracy to commit same), and the ACTUAL PERJURY by Trooper John Nelson at his deposition on January 21, 2015, were not the only instances of DISHONESTY and CRIMES INVOLVING MORAL TUPITUDE in matters involving me. Let me expand on these charges. I will be sending you, under separate cover (I hope to mail them to you later today), copies of the following: ENCLOSURE NO. 1, which consists of three pages of a series of photographs taken by Photographer David Spielman of New Orleans in September 2005, which show 12 numbered wounds to my lower extremities (thighs and knees), caused by "hits" from bean-bag rounds fired at me by a sociopath employee of the Louisiana Department of Public Safety and Corrections at Camp Amtrak during the early morning of September 20, 2005. Ten (10) of the bean-bag rounds were fired from a 12-gauge shotgun, at point blank range, inside the Camp Amtrak building, while my hands were cuffed behind my back. Two (2) of the rounds, one (1) to each leg, were fired at me while I was in a Guantanamo-style "dog-cage", with the gate locked, with the barrel of the shotgun protruding through the links of the chain-link fence, aimed at me from the outside of the "dog-cage". The sociopathic shooter was actually aiming at my genitals for these two (2) shots, egged on by a Supervisor, who shouted the following orders to his lackey: "Hit him in the dick! Shoot him in the balls!" Fortunately, the shooter "missed". ENCLOSURE NO. 2, which appears to be an "Unusual Occurrence (Use of Force)" report, purportedly signed by Lieutenant Matt Reed of the "P.S.P. (for 'Louisiana State Penitentiary') Tactical Unit", and bearing a date of 9/20/05. I do not know the details concerning the preparation of this report; however, I can state unequivocally that Reed LIED in the report, several times. While Reed admits that he shot me three (3) times while I was on the other side of the chain link "dog-cage" fence from him, I actually was shot only twice while in the "dog-cage". And Reed conveniently omits the ten (10) other "hits" by beanbag rounds, which he fired at me (there was only one shooter) while I was inside the Camp Amtrak building, with my hands cuffed behind my back. See the total of twelve (12) wounds visible and individually numbered in the photographs. If, as Reed states, he shot me three (3) times outdoors (I say twice), then nine (9) or ten (10) shots are unaccounted for in his signed report, BECAUSE REED IS A LIAR. In addition, I was "pepper-sprayed" 30 to 40 times IN THE FACE while at Camp Amtrak, not once as Reed admits in his statement. The allegation that I attempted to climb the fence is absurd. Where was I going to go, even if I successfully reached the concertina wire at the top of the chain-link fence? The suggestion that I was "triaged" by any EMT is also a lie, although two un-uniformed individuals, who asked me if I needed any "first aid", did come to my "dog-cage" nine (9) to ten (10) hours later, during the daylight hours. I refused any "first aid" as an act of defiance. There are other LIES by Reed in his statement, but these will suffice for now, SINCE THE PHOTOGRAPHS OF THE TWELVE (12) WOUNDS WHICH REED INFLICTED ON ME WITH A 12-GAUGE SHOTGUN LOADED WITH BEAN-BAG ROUNDS DON'T LIE. ENCLOSURE NO. 3, which is my "Motion (and Incorporated Memorandum) To Disqualify and Recuse 'Special Counsel' Fred McGaha on Grounds of Criminal Conduct (Subornation of Perjury), Etc." In this document, which was filed in Docket No. 13-PDB-122 before the Louisiana Attorney Disciplinary Board on May 28, 2014, I PREDICTED NELSON'S PREJURY AND MCGAHA'S SUBORNATION OF SAME, and tried to "nip it in the bud", or at least make Nelson think twice about committing PERJURY at a deposition by refusing to LIE under oath and to invoke the Fifth Amendment. Call me "prophetic". I invite you to compare what I predicted would happen, long before Nelson's deposition, with his PERJURED deposition testimony. Parenthetically, do you have the transcript of Nelson's deposition? If not, why not? Who have you asked for a copy? What have they told you? If you take the time to READ Enclosure No. 3, you will see that Nelson's deposition testimony is UNWORTHY OF BELIEF and that he has CONTRADICTED HIMSELF in several instances. ENCLOSURE NO. 4, which is my "List of Exhibits" in Docket No. 2010-DB-006 before the Louisiana Attorney Disciplinary Board, filed on November 13, 2014. This enclosure documents LIES - really PERJURY under oath - by Louisiana Chief Disciplinary Counsel Charles B. Plattsmier, Jr. (See pages 13 through 16), as well as BALD-FACED LIES told by former Chief Justice of the Louisiana Supreme Court, Catherine Dick Kimball (See pages 7 through 12, and 57 and 58). I cannot afford to make copies of the many Exhibits to Enclosure No. 3, but I have them here in my "one-room efficiency apartment" for review or copying by your designee(s), if you wish to see them. You also can obtain them from the Louisiana Attorney Disciplinary Board, electronically, if you ask for them. So, Colonel Edmonson and Lt. Col. Dupuy, Trooper John Nelson, McGaha and Ms. Stewart don't have a "corner" on PERJURY, SUBORNATION OF SAME, OBSTRUCTION OF JUSTICE, AND CONSPIRACY COMMIT SAME in matters involving me. Please identify to whom you have reported the crimes I have identified to you with the FBI, and who will be my "point of contact" with that agency. Thank you. Ashton O'Dwyer.
