Madame:

This acknowledges receipt of your missive of earlier today, with attachment.

You and the Colonel, and perhaps some of your other colleagues, are looking at my Formal Complaint too myopically.

My allegations are not "baseless". The photographs of the physical injuries which were inflicted upon me do not lie. My medical records do not lie. If I had been a convicted murderer, armed robber or rapist, I did not deserve the brutal treatment I received at the hands of colleagues of yours with the Louisiana Department of Public Safety and Corrections, which included State Policemen and Corrections "Officers" (actually "GOONS from Angola). And the GOONS who brutalized and tortured me were sent on their mission by others identified in my Formal Complaint of August 14, 2017, which I supported in meticulous detail with subsequent documents transmitted to Colonel Reeves. (For some reason, I failed to include former Colonel Henry Whitehorn as a transgressor and co-conspirator, but I add him now, as someone who participated in a criminal conspiracy to commit civil rights violations and to deny civil rights),

Nor are my allegations "prescribed", as you aver. If you are a lawyer (assumed to be the case, since you appear to work in the DPS Office of Legal Affairs), then you must have heard of "The Doctrine of Continuing Offenses", which is applicable to my situation, and which caused any prescriptive period to be interrupted when the conspiracy to suborn and commit perjury was hatched (January 2015), and then to obstruct justice by appointing the "perjury suborner", McGaha, to investigate my allegations of perjury and subornation of same. More evidence of the continuing criminal offenses against me is the failure to investigate and the "cover-up" by Colonel Edmonson, Lt. Col. Dupuy and Major Flinchum. These are things that have "changed materially and factually" if one looks at my Complaint through honest eyes, and doesn't simply "sweep it under the rug" in order to protect some powerful people (and by so doing, engaging in "new" affirmative acts of obstruction of justice, which is a separate crime.

Even if you are right and I am wrong, and the underlying criminal conduct has prescribed, Colonel Reeves, the Louisiana State Police and the DPS can still institute DISCIPLINARY PROCEEDINGS against people who shouldn't be wearing badges and who shouldn't be carrying guns.

This is for the attention of the Superintendent of the Louisiana State Police, Colonel Kevin W. Reeves. Dear Sir: This is a Formal Complaint of criminal conduct by Louisiana State Troopers and others. The crimes committed by the following individuals include the following:

- (1) Sergeant Christopher Ivy (Badge Number 1139) civil rights violations (including battery), falsification of a Louisiana public record, subornation of perjury and participation in a criminal conspiracy to deny civil rights and to obstruct justice.
- (2) Trooper John Nelson (Badge Number 2227) civil rights violations (including battery), participation in the falsification of the contents of a Louisiana public record, perjury during his deposition on January 21, 2015, and participation in a criminal conspiracy to deny civil rights and to obstruct justice.
- (3) Former Louisiana State Penitentiary Warden Burl Cain civil rights violations (including aggravated battery) and conspiracy to commit same.
- (4) Louisiana State Penitentiary Tactical Unit Lieutenant Matt Reed civil rights violations (including aggravated battery) and conspiracy to commit same, and falsification of a Louisiana public record as part of a criminal conspiracy to deny civil rights and to obstruct justice.
- (5) Assistant District Attorney Fred McGaha of Ouachita Parish subornation of perjury by Trooper Nelson during Nelson's deposition, and participation in a criminal conspiracy to deny civil rights and to obstruct justice.
- (6) Former Louisiana State Police Superintendent Colonel "Mike" Edmonson subornation of perjury and participation in a criminal conspiracy to deny civil rights and to obstruct justice.
- (7) Louisiana State Police Lieutenant Colonel Charles Dupuy subornation of perjury and participation in a criminal conspiracy to deny civil rights and to obstruct justice.
- (8) Louisiana state Police Major Cathy Flinchum subornation of perjury and participation in a criminal conspiracy to deny civil rights and to obstruct justice.

The on-going criminal conspiracy which I am reporting to you (the "new Sheriff in town") was hatched on September 11, 2005, in the Baton Rouge Office of former Louisiana Attorney General Charles C. Foti, Jr., culminating in a "criminal gangland-style hit" on me by Trooper Nelson and others at my then-home at 6034 St. Charles Avenue in New Orleans, at 5 minutes past midnight on September 20, 2005. The conspirators include many more people than those I have identified to you, including a former Louisiana Supreme Court Chief Justice and her Chief Disciplinary Counsel, among many others. Notwithstanding the fact that some of the violations of Title 14 occurred in the aftermath of Hurricane KATRINA, since the criminal conspiracy to deny my civil rights, to obstruct justice, and to "cover-up" the crimes committed against me continue

to this day, the "Rule of Continuing Offenses" applies, meaning that prescription has not yet run, rendering ALL of the crimes "prosecutable".

You should know that I previously reported some of these crimes to your predecessor, Colonel Edmonson, through his then-Administrative Assistant, Ms. Rhonda Fogleman, who can provide you with further background and documentation. Not only did Colonel Edmonson do NOTHING, but he referred my Formal Complaint of perjury by Trooper Nelson at his deposition to the actual "perjury suborner", McGaha! That was Colonel Edmonson's brand of "justice" here in "Louseyanna".

And notwithstanding your personal "history" with Troop "F", and "connections" to "the law enforcement scene" in Monroe, I am hoping that you will do your sworn duty and seriously investigate the crimes that I have reported to you, and ultimately take appropriate disciplinary action and referral for criminal prosecution. I stand ready to be interviewed by LSP Investigators, under oath, and to cooperate fully with the LSP in any way which may be requested.
