Narrative

On January 01, 2022, at approximately 2216 hours, I, Deputy Baily Romero, employed with St. Martin Parish Sheriff's Office, Patrol Division, conducted a traffic stop near the 1200 block of Bayou Alexandre Highway.

While patrolling in my marked Patrol unit, I observed a white male subject, traveling west in the east bound lane on Bayou Alexandre Highway. I did not observe any lights or reflectors on the subjects bicycle. I shined my spotlight on the subject, at which point, I observed him throw a small plastic baggie on to the roadway. I pulled up to the object and recognized it to be suspected methamphetamine, a crystal like substance, packaged in a small plastic baggie.

I activated my overhead emergency lights, initiating a traffic stop on the subject. The suspect did not stop immediately. Once he did approximately 100 yards, from where I activated my lights, the subject refused to turn around and look at me. I drew my service weapon and ordered the subject off of the bike, due to not being able to see his hands.

I gave him commands to exit his bike and lay on the ground, which he finally complied to after I gave him K-9 warnings. I approached the subject and placed the subject in handcuff's double-locked and checked for fit.

I escorted the subject to the front of my patrol car and advised him of his rights as they pertain to Miranda, which he stated he understood and still wished to speak.

I identified the subject as Dalton Boudreaux. Dalton informed me he did not throw the suspected methamphetamine, that it accidentally fell from his person, ironically at the same time he was aware of my presence.

I secured the evidence in my patrol unit. I gathered Daltons information and informed him that I will be issuing a warrant for his arrest. I then released Dalton from the scene and transported the evidence to 4870 Main Highway, for processing and secured it in the evidence locker.

I have submitted an arrest warrant to the Honorable Judge, Lewis Pitman, for the violations of LA. R.S. 32:329 Bicycle Lamps, 40:967C Possession of Schedule II and 14:130.1 Obstruction of Justice.
