PROBABLE CAUSE IS:

On October 5, 2023, at about 1916hrs; I, Deputy Gregory Brant Aydell LP355, with Livingston Parish Sheriff's Office Uniform Patrol Division, was dispatched to 13170 Keila Road in Killian, LA in reference to a reported crash involving a hit and run. The caller, identified as Cody M. Bowlin, stated to LPSO dispatchers that he had been involved in a crash with a Uhaul truck and that the Uhaul driver, later identified as William King, was attempting to flee. According to Bowlin at the time of the call, he informed dispatchers that the crash occurred at Fairway and Keila Roads. Cody then stated to dispatchers that he was attempting to block King in via the use of his vehicle. Upon the Affiant's arrival, Springfield Police Department Officer Brice SP3 was on the scene with Cody and a witness. The affiant then began to question Cody as to what occurred. Cody stated that his girlfriend, Ania Kioztowski, had hired William King, to assist in moving some furniture from her camp in Killian. Cody stated that he knew King through a sober living facility, but was unable to provide the affiant with King's name. Continuing, Cody stated that he did not live at Ania's residence, but was simply assisting in loading furniture. According to Cody, he went inside to get a flashlight and exited to King leaving the residence in the Uhaul. Cody then stated to the affiant that he entered his 2020 silver GMC truck and attempted to block in the Uhaul, believing that King was attempting to steal it. King was able to ultimately able to escape the yard/driveway in the Uhaul, with Cody giving chase, through the neighboring roads. Cody stated that he attempted several times to cut the Uhaul off and block it with his vehicle to keep King from leaving. At one point during the pursuit, Cody stated he and King traveled through multiple residential yards before he was able to block the street with his truck. That is when Cody stated that King struck his passenger front side with the Uhaul in an attempt to escape. In hearing this, the deputy then advised Cody of his rights pursuant to Miranda. Cody stated he understood. Port Vincent Police Officers Chief Stafford PV1 and Ofc. Price PV3, were able to conduct a traffic stop with King and the Uhaul at the intersection of Hwy 16 and La 42. Upon request, Cody provided the affiant with Ania's phone number, who he then contacted. During the recorded phone conversation with Ania, she stated that King was hired by her and instructed to return to her residence in Baton Rouge with the Uhaul. Ania further stated she is in no intimate relationship with Cody, nor does he reside with her. The affiant then confirmed with Ania that the Uhaul was rented under her name. Subsequently LPSO Dy. Patterson LP347 contacted King at the traffic stop and questioned him in regard to what occurred. King informed Dy. Patterson that he was hired by Ania to move her things, but that when he found out Cody was going to steal it, he phoned Ania who instructed him to return to Baton Rouge in the Uhaul. King further stated to Dy. Patterson that when he attempted to leave, Cody blocked him in, continued to chase him in his truck, intentionally ran into the Uhaul, and pointed a gun at King who was trying to escape. King was then given a voluntary statement to fill out by Port Vincent Police Department Officers. The affiant then spoke with a witness to the incident, Logan Scuderi, who stated he observed Cody chasing King in his truck. Scuderi confirmed that Cody did in fact chase King through multiple streets and residential yards, before ultimately trying to block the road. The affiant then inspected the damage to Cody's vehicle, observing front passenger side damage to the bumper, headlight housing, fender well, wheel, and scraps down the passenger side of the truck. Based on the information provided by Ania Kioztowski, William King, and the witness Logan Scuderi, when combined with the physical evidence present on the truck; Cody Bowlin was placed under arrest. LPSO communications previously advised the affiant that Cody was wanted on a fugitive warrant through EBRSO, that he did possess an active protective order in NCIC (512045), and that Cody was a convicted felon per his criminal history results. Upon further inspection of the 2020 GMC truck Cody was operating, the affiant and Ofc. Brice SP3 observed suspected marijuana within a clear cellophane baggy in plain view near the center console. The affiant then questioned Cody as to whether he possessed a valid prescription for smokable marijuana on his person, which he denied. During a search of the vehicle, the affiant located approx. 7.0 grams of suspected marijuana, "Raw" brand rolling papers, one rolled suspected marijuana cigarette and a short-cut snort straw. In the rear passenger seat of the truck, within a tan bag labeled with Cody's initials (CMB), the affiant located a loaded Smith and Wesson M&P 45 caliber pistol. Cody was then transported to LPDC where he was booked on the aforementioned violations of the Louisiana Revised Statutes.

WITHIN THIS STATE AND PARISH, AND THE JURISDICTION OF THE 21<sup>ST</sup> JUDICIAL DISTRICT COURT, CONTRARY TO THE FORM OF THE STATUTES OF THE STATE OF LOUISIANA IN SUCH CASE MADE AND PROVIDED, AND AGAINST THE PEACE AND DIGNITY OF THE SAME.

WHEREFORE, DEPONENT PRAYS THAT THE SAID ACCUSED BE ARRESTED AND DEALT WITH ACCORDING TO THE LAW.
