WHEREAS, the term "special legal counsel" envisioned by Section 4-02(D) of the Home Rule Charter for St. Martin Parish has always been viewed by both the Parish President and the Parish Council as meaning an attorney who specializes in select, esoteric fields such as tax law, bond matters, reapportionment, and civil rights; furthermore, the said term does not embrace counsel who ordinarily defend litigation claims;

WHEREAS, Chester R. Cedars served as general counsel for the ST.

MARTIN PARISH GOVERNMENT from January 1, 2000, the inception date of
the Home Rule Charter until July 1, 2016:

WHEREAS, both the Parish President and the St. Martin Parish Council have expressed the desire that all litigation matters involving the St. Martin Parish Government be handled by Chester R. Cedars at a special rate fixed by the Parish President;

WHEREAS, by virtue of Resolution Number ________, adopted on the ________, adopted on the ________, adopted on the ________, the St. Martin Parish Council affirmed its posture relative to its general counsel and the defense of litigation claims;

WHEREAS, by virtue of the aforesaid resolution, the ST. MARTIN PARISH GOVERNMENT acknowledged that in all litigation claims where the said Chester R. Cedars cannot assume the Parish's defense, then the Parish President will reassign the subject litigation defense to another attorney, at his discretion, and for a fee to be fixed by the Parish President;

WHEREAS, both the Parish President and the St. Martin Parish Council acknowledge that the representation of St. Martin Parish by Chester R. Cedars as general counsel, and in selective litigation matters, has never been, and is not currently, the product of any solicitation by him; rather, the ST. MARTIN PARISH GOVERNMENT solicited his representation;

WHEREAS, the legal relationship between the ST. MARTIN PARISH GOVERNMENT and the said Chester R. Cedars has been a significant benefit to the public served by the ST. MARTIN PARISH GOVERNMENT;

WHEREAS, Chester R. Cedars meets all of the requirements of Section 4-02(B) of the St. Martin Parish Home Rule Charter relative to serving as general

NOW, THEREFORE, acting pursuant to the dictates of the Home Rule Charter of St. Martin Parish:

CHESTER R. CEDARS whose current mailing address is Post Office Box 845, Breaux Bridge, Louisiana, 70517, (hereinafter referred to as "ATTORNEY"),

do hereby enter into this agreement under the following terms, conditions, and provisions:

ARTICLE I. Purpose and Nature of Venture.

The venture embraced by this accord calls for the agreement by **ATTORNEY** to accept the appointment of general counsel or parish attorney for the **PARISH GOVERNMENT**, all in accordance with Section 4-02 of the Parish's Home Rule Charter.

ARTICLE II. Compensation.

In consideration of the terms and conditions set forth herein, the PARISH GOVERNMENT shall pay unto ATTORNEY the sum of FIVE THOUSAND AND NO/100 (\$5,000.00) DOLLARS per month, due and payable on the tenth day of each month. This sum represents, solely and exclusively, compensation for services as general counsel. Moreover, because of ATTORNEY'S duties as general counsel, he

ARTICLE III. Duties and Responsibilities.

The duties and responsibilities of **ATTORNEY** shall be to serve as general counsel for the **PARISH GOVERNMENT**. It is agreed that the scope of the representation of **ATTORNEY** as Parish Attorney will not include the defense of any litigation, workers' compensation claims, and/or any matters which require special counsel as that term is envisioned by Section 4-02(D) of the Home Rule Charter. As general counsel, **ATTORNEY** shall be available to consult with **PARISH GOVERNMENT** seven days a week on an "as needed" basis. Thus, **ATTORNEY** shall have in his name and for his use a cellular telephone which he shall be obligated to maintain and secure services with a reputable provider.

Nothing set forth herein, however, shall preclude ATTORNEY from assuming the representation of the PARISH GOVERNMENT in any litigation matter; nonetheless, any such defense/representation shall be viewed as a separate contract between ATTORNEY and the PARISH GOVERNMENT and shall not be governed by any term, condition, or provision of this instrument. However, should ATTORNEY assume the representation of the PARISH GOVERNMENT in any such litigation, he shall be compensated at the rate of ONE HUNDRED SEVENTY-FIVE AND NO/100 (S175.00) DOLLARS per hour, plus reimbursement for all normal, reasonable, and ordinary expenses of litigation including reproduction costs, depositions, postage and handling, and travel outside the Parish of St. Martin. ATTORNEY shall bill the PARISH GOVERNMENT monthly, and all invoices shall be itemized.

ARTICLE IV. Term.

The term of this venture shall be indefinite. Hence, either party may terminate this accord by giving the other written notice thirty (30) days in advance of the termination date. In no event shall the contract extend beyond January 1, 2020.

ARTICLE V. Effective Date.

This agreement shall be effective retroactively to May 15, 2017, notwithstanding the date of the execution of this accord.

ARTICLE VI.

Legal services shall be provided by **ATTORNEY** in the capacity of an independent contractor, and nothing set forth herein shall be construed to create an employer-employee or master-servant relationship. **ATTORNEY** understands and acknowledges that he is solely responsible for any employment, labor, industry, business, property or income tax obligations arising from the confection of this accord, and that the **PARISH GOVERNMENT** shall not withhold or pay any taxes on his behalf in connection herewith.

ARTICLE VII. Drafting of Accord and Interpretation.

ATTORNEY and the PARISH GOVERNMENT have jointly participated in the negotiation and drafting of this agreement. Consequently, in the event that ambiguity or a question of intent or interpretation arises, this document shall be construed as if drafted jointly, and no presumption or burden of proof shall arise disfavoring or favoring any party by virtue of the authorship of any provision hereof.

ARTICLE VIII. Counterparts.

ARTICLE IX. Severability.

If any provision of this instrument or application thereof to any person or circumstance is held invalid, such invalidity will not affect the other provisions or applications of this instrument which can be given effect without the invalid provision or application, and to that end, the provisions hereof are declared to be severable.


