





## **RELEASE AND SETTLEMENT AGREEMENT**

This Release and Settlement Agreement ("Agreement") is entered into between **Cathy Derbonne** ("Derbonne") and the **Louisiana State Police Commission** ("the Commission") as follows:

**WHEREAS**, Derbonne separated from employment with the Commission on January 12, 2017;

**WHEREAS**, disputes exist between Derbonne and the Commission arising out of Derbonne's employment as asserted by Derbonne in her Petition for Damages and her Supplemental, Amending, and Restated Petition entitled, "Cathy Derbonne v. State Police Commission" filed in the 19<sup>th</sup> Judicial District Court, Parish of East Baton Rouge, State of Louisiana, bearing Suit No. 665,201, Division 23.;

**WHEREAS**, the parties hereto have agreed to settle the above-referenced disputes and to compromise and settle all known and unknown claims and causes of action of any nature whatsoever relating in any way to the claims Derbonne may have against the Commission;

**NOW, THEREFORE**, in consideration of the mutual promises set forth herein, the parties agree as follows:

1. The Commission agrees to pay to Derbonne the total sum of \$130,000.00 (One Hundred and Thirty Thousand Dollars and 00/100), the receipt and sufficiency of which is hereby acknowledged by Derbonne. This payment will be sent to Derbonne in two (2) checks made payable as follows: (1) to "Cathy Derbonne" in the amount of Eighty-Six Thousand, Six Hundred Sixty-Six Dollars and 67/100 (\$86,666.67), which represents a settlement of Derbonne's claim for medical and other expenses incurred in connection with emotional distress and other damages suffered and Derbonne contends they include bodily injuries; and (2) to "Jill L. Craft, Attorney at Law" in the amount of Forty-Three Thousand, Three Hundred Thirty-Three Dollars and 33/100 (\$43,333.33), representing payment of attorney fees and costs and for which an IRS Form 1099 will issue. The checks will be sent to Derbonne's attorneys, Jill L. Craft, Attorney at Law, within fifteen (15) days after receipt by the Commission of an executed copy of this Agreement, as well as the appropriate IRS Forms. To the extent a 1099 must issue to Ms. Derbonne, the 1099 will not reflect payment of wages or income but only reflect settlement of personal injury and emotional distress damages." The total payment of \$130,000.00 represents all monies owed by the Commission to Derbonne in connection with this Agreement, including but not limited to any attorneys' fees and costs.



2. In return for, and in consideration of, the total payment discussed in Paragraph 1 above, Derbonne releases the Commission, the Commissioners, directors, executives, managers, agents, attorneys, supervisors, employees, and insurers (hereinafter "the Released Parties") from all legal claims, demands, liabilities and actions of any kind existing as of this date, whether known or unknown, which relate to or arise out of the services that she provided to the Commission, including but not limited to any and all claims arising under the laws of the State of Louisiana, including claims arising under the Louisiana Employment Discrimination Law, La. R.S. 23:301, et seq; the Louisiana Whistleblower Act, La. R.S. 23:967, the Louisiana and Federal Constitutions, and arising under any and all other federal, state and local laws and regulations prohibiting, without limitation, discrimination or harassment in employment, retaliation, conspiracy, tortious or wrongful discharge, assault and battery, breach of an express or implied contract, breach of a covenant of good faith and fair dealing, negligent or intentional infliction of emotional distress, defamation, misrepresentation or fraud, detrimental reliance or any other offense, quasi-offense or delictual or contractual or quasi-contractual claim which Derbonne may have, may ever have had or may ever have against the Released Parties, including any claims which were, could be or could have been asserted by her upon or by reason of any matter, cause or thing, up to and including the day on which Derbonne executes this Agreement, including but not limited to any and all claims Derbonne brought or could have brought in the Litigation and any and all claims related to the time period during which she provided services to the Commission and any of the Related Entities, and any and all claims relating in any manner to such claims. It is the intent of the parties to fully and finally compromise and settle all matters of any nature between the parties which have arisen through and including the date of this Agreement. This is a general release and should be construed as broadly as possible.

This Release excludes, and Derbonne does not release, waive or discharge: (i) claim(s) under state workers' compensation or unemployment laws; (ii) indemnification right(s) the Employee has against Employer; and/or (iii) any other right(s) or claim(s) that cannot be waived by law.

3. Derbonne releases all claims against the Released Parties willingly, freely, without duress and after having had her rights under all of the above laws fully explained to her by her counsel of choice, Jill L. Craft, Attorney at Law, and Derbonne further understands that if a court found in her favor, she could possibly receive an award or judgment for a larger sum than she received.

4. Derbonne also agrees that if she has filed any lawsuit, charge, claim, complaint or demand against the Released Parties for matters being released in Paragraph 2 above, then she will withdraw or dismiss the lawsuit, charge, claim, complaint or demand with prejudice and at her own cost and that she will file no other lawsuit, charge, claim, complaint or demand arising out of any matter released in Paragraph 2 above.

5. It is specifically understood and agreed that the Commission is not admitting liability in any respect whatsoever. Instead, this settlement is being made in the spirit of compromise and in order to avoid litigation.

6. Nothing in this Agreement prohibits or restricts Derbonne from filing an administrative charge or complaint with, or testifying, assisting, or participating in an investigation, hearing or proceeding conducted by, the Equal Employment Opportunity Commission (EEOC), the National Labor Relations Board (NLRB), the Occupational Safety and Health Administration (OSHA) or any other federal, state or local government agency, although by signing this Agreement the Employee waives, to the fullest extent permitted by law, any right to monetary or other relief (including front pay, back pay, reinstatement or other legal or equitable relief) related to any charge or complaint or other proceeding brought by the Employee or on the Employee's behalf by any third party, except for any right the Employee may have to receive an award from a government agency for information provided to the government agency.

Moreover, nothing in this Agreement prohibits, restricts or impedes Derbonne from exercising rights under Section 7 of the National Labor Relations Act (NLRA) to engage in joint activity with other employees.

Furthermore, nothing in this Agreement shall prohibit, restrict or impede Derbonne from exercising any other protected rights to the extent that such rights cannot be waived by agreement, or from complying with any other applicable law or regulation or valid order or request of a court of competent jurisdiction or authorized government agency, provided that such compliance does not exceed what such a law(s), regulation(s) or order(s) requires to be non-waivable by agreement.

7. Derbonne acknowledges that the settlement represents a compromise settlement of Derbonne's alleged damages. Derbonne understands that she is responsible for paying any federal, state, or local taxes on amounts received under this Agreement, if any, and the Commission makes no representation regarding any such liability. Derbonne unconditionally agrees to hold the Commission harmless, and to indemnify the Commission, from any and all liability which may be asserted against it by any taxing authority in connection with any taxes for which she is responsible as a result of this settlement.

8. Derbonne materially represents that she is the only person that has or had an economic or legal interest in this matter, other than her legal counsel identified herein. Derbonne agrees that if any person or entity claims an economic or other interest in these settlement funds, including any debtor, trustee, lien holder, or any bankruptcy court or agent, such interest is their sole responsibility and not that of the Commission. Thus, if any attorney's fees or sums are owed in connection with this matter that are not set forth



herein, Derbonne is personally responsible for payment of such fees out of the settlement proceeds or otherwise, and he unconditionally releases and discharges the Commission from any claim for any such interests, including attorney's fees and costs to Jill L. Craft, Attorney at Law, or any other law firm.

9. As a term of this Agreement, the parties have fully considered Medicare's interests pursuant to the Medicare Secondary Payer rules, and in doing so, Derbonne has declared and hereby affirms that (a) Derbonne is not Medicare eligible, (b) Derbonne is not enrolled in the Medicare program, (c) Derbonne was not enrolled in the Medicare program at any relevant time or anytime thereafter through the date of this Agreement, and (d) Derbonne has not received Medicare benefits (either through ordinary Medicare or Medicare Advantage) for medical services or items related to, arising from, or in connection with the claims released in this Agreement. Derbonne represents and warrants that no Medicare payments have been made to or on behalf of her and that no liens, claims, demands, subrogated interests, or causes of action of any nature or character exist or have been asserted arising from or related to any of the claims released in this Agreement. Derbonne further agrees that she, and not any of the Released Parties, shall be responsible for satisfying any and all such liens, claims, demands, subrogated interests, or causes of action that may exist or have been asserted or that may in the future exist or be asserted. Based on these representations made by Derbonne, the parties have determined that Medicare has no interest in the payments under this Agreement and no reporting is required to Medicare. However, if Medicare (or the agency representing Medicare's interests) later determines that it does have an interest in the payment to Derbonne under this Agreement, Derbonne agrees to indemnify the Released Parties as soon as possible for any payments the Released Parties are required to make to Medicare (or the agency collecting on behalf of Medicare) as a result of the payments under this Agreement. Derbonne acknowledges and understands that in making payment to her pursuant to this Agreement, the Commission is reasonably relying on the representations and warranties made by Derbonne herein and these representations and warranties are a material inducement to the Commission to make payment as part of this Agreement.


10. Derbonne waives any right of reinstatement to, or employment or re-employment with the Commission. If Derbonne applies for work, or reapplies for work, in the future with the Commission, then this Agreement will be a sufficient reason, by itself, for her not to be hired or re-hired.

11. If any provision of this Agreement is held invalid, the parties agree that the remainder of the Agreement shall not be affected thereby and shall remain in full force and effect.

12. Derbonne attests that no other representations or inducements were made regarding the Agreement other than those contained herein. All prior agreements and understandings relating to this Agreement are hereby voided and/or superseded.

13. Derbonne has had ample opportunity to review and consider this Agreement, and she has read and fully understands it. She has signed this Agreement freely, voluntarily and with the full knowledge that she is waiving all claims against the Released Parties.
