Subject: Formal written charges and request for investigation.

Madame: I am making formal written charges against Louisiana State Trooper John Nelson, who I believe is assigned to "Troop F" in Monroe, La. I also am making a formal request for an investigation of my allegations, all pursuant to the Commission's Rules, and particularly Chapter 16. Nelson violated my civil rights by virtue of an ILLEGAL "arrest" on September 20, 2005, at 6034 St. Charles Avenue, New Orleans, La. 70018, and participated in a conspiracy to deprive me of my civil rights, and to have me tortured, brutalized and falsely imprisoned at Camp Amtrak in the aftermath of KATRINA. I also aver that Nelson committed PERJURY during a deposition on January 21, 2015. I do not drive, and getting to Baton Rouge to present my evidence to the Commission would be virtually impossible for me. Accordingly, I propose that your Investigator should visit me at my current home at 1116 Monticello Avenue, Jefferson, La. 70121 to conduct an interview, under oath. This also is a reasonable proposal, because I have all relevant documents here at my home, including the transcript of a statement made under penalty of perjury to the Louisiana Department of Justice (who were complicit in the violation of my civil rights, although I didn't know that at the time) on October 14, 2005. As I explained to you, Colonel Edmondson, Lt. Col. Dupuy and Ms. Flinchum are all conspiring, along with Assistant District Attorney Fred McGaha of Ouachita Parish, to obstruct justice and "cover up" the wrongdoing in my case. Accordingly, I am requesting an "independent" investigation of my allegations against Nelson. Ms. Fogleman, Colonel Edmondson's Administrative Assistant, has relevant documentation which will be meaningful to you. In the meantime, let me refer you to the following video "links":
