JUDGMENT

This matter came before the Court for a Rule Date on December 7, 2015 pursuant to a Request for Civil Warrant to Obtain Return of Child and Rule for Contempt and Child Support filed by Mr. Holliday on August 5, 2013 and a Rule to Modify Custody and Child Support Obligation filed by Ms. Sumrall on September 3, 2014. Present in court were Amy Holliday (Sumrall) and her attorney, Michael S. Walsh and Stephen Holliday and his attorney, Thomas Gibbs. The Court after reviewing the pleadings filed, the evidence and testimony presented ruled as follows:

IT IS ORDERED, ADJUDGED AND DECREED that the child support obligation for Mr. Stephen Holliday is set at \$604.00 per month, payable in two equal payments of \$302.00 due on the first and the fifteenth of the month with the first payment being due on January 1, 2016 to Amy Sumrall.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that Stephen Holliday shall be responsible for 41% and Amy Holliday (Sumrall) shall be responsible for 59% of any uncovered expenses for medical, dental, vision as well as extra-curricular activities for the minor child, Alexandra Holliday.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that Stephen Holliday owes \$4,686.00 in retroactive child support for the minor child, Alexandra through December 31, 2015. One-half or \$2,343.00 is due within thirty (30) days and the balance (\$2,343.00) will be paid at the rate of \$300.00 per month for eight (8) months until it is paid off.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that both parties maintain insurance coverage on the minor child, Alexandra and the Mr. Holliday provide Ms. Sumrall with an insurance card.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that Mr. Holliday reimburse Ms. Sumrall for his share (41%) of the orthodontic costs of \$3,500.00, totaling \$1,435.00.


IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that Mr. Holliday reimburse Ms. Sumrall for 50% of the cost of counseling with Allyson McCain for the minor child or \$1,125.00.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that Mr. Holliday delivers to Mr. Gibbs's office all of the minor child's belongings, clothing, shoes and personal items within fourteen days. Mr. Walsh agrees to pick up the belongings and deliver them to his client.

IT IS FURTHER, ORDERED, ADJUDGED AND DECREED that this matter is set for a Judgment Review hearing on January 19, 2016 at 9:00 a.m.
