Defendant appeals to this Honorable Court as the ruling and/or decision rendered by the Louisiana State Board of Cosmetology was in excess of the statutory authority of the agency, was made upon unlawful procedure, was affected by other errors of law, was arbitrary and capricious or characterized by abuse of discretion or clearly unwarranted exercise of discretion


