Dear Mr. Meche:

Your request summarized below, dated August 9, 2012 and which was addressed to the Louislana State Police was forwarded to me for consideration and response. An initial response to your request was sent via fax and US Mail on August 20, 2012. In your letter you requested documentation showing the number of driver's license check and criminal history checks processed through LLBTS on a daily basis and yearly totals for 2006-2010 by Law Enforcement personnel and separately by private investigators and any other non-law enforcement groups with access.

Please find below the system-wide number and types of checks done in the years reflected. Due to the volume of requests, it is extremely burdensome, and would be detrimental to the operations of the Department to attempt to compile a daily breakdown of these numbers. State law, federal law and he rules and policies governing access to these databases do not allow for access for non-criminal justice purposes. There is no non-law enforcement access to these databases.
