Mr. Hannaman,

Please accept this letter as my formal response to the erroneous allegations levied against me on January 10, 2019 at our monthly Louisiana State Police Commission meeting held in Baton Rouge, Louisiana.

At that meeting, I was falsely accused of contributing to a political campaign in July 2017. In actuality, my brother Denis Riecke is the individual that was solely responsible for planning and hosting a fundraiser for a local state representative.

Enclosed in this response you will find six (6) documents that refute the allegations and provide evidence I had nothing to do with the planning, execution, or payment of this event.

The first document is a letter from Mr. Mark Wright, State Representative for District 77. This letter is dated January 10, 2019 and extends Mr. Wright's sincere apology for mistakenly attributing an in-kind contribution to Riecke and Associates, LLC when in truth and fact the contribution (i.e. the catering for the event) was paid for by Denis Riecke and not Riecke and Associates, LLC.

The next two documents are labeled Schedule A-2: In-Kind Contributions. The first one shows Riecke and Associates, LLC incorrectly listed as a contributor for the event. The second document shows the official document has been corrected by Mr. Wright to reflect Denis Riecke personally as the contributor and removing any reference to Riecke and Associates, LLC.

Document number four is a copy of the invitation for the event. Of note you will see neither my name personally nor Riecke and Associates, LLC appears anywhere on this invitation.

Document number five is a receipt from the restaurant where the fundraiser was held. Of note, you will see the receipt is made out to Denis Riecke on July 11, 2017. It states that it is an invoice for the Mark Wright Campaign Event totaling \$500. You will also notice in the bottom right hand corner that it is been signed by, what one would assume is, a member of the restaurant personnel. In that hand writing it states "Dennis paid \$500 cash".

The final document, document number six, is a notarized affidavit signed by Denis Riecke. This affidavit states that he, in his individual capacity, sponsored and funded the political event in question. It also states that no other person or entity contributed to nor participated in the payment for this event.

I take the seriousness of serving on the Louisiana State Police Commission deeply to heart. Since I have been on the Commission (sworn in on June 17, 2016), I have at no time sponsored, planned, attended, financed, or in any way taken part in any political fundraiser for any individual, or political party.

I hope my vindication of these charges will be as vigorously and aggressively made public as was the original allegation.

If you need anything further from me, please do not hesitate to immediately let me know.

Thank you for your diligent efforts on the behalf of this investigation.
