MOTION TO CANCEL OR REDUCE BOND  
TO ALLOW MENTAL HEALTH TREATMENT

MOVER MICHAEL SATCHER, through his attorney Todd Farrar and attorney F. Rae Swent, requests that this Court reconsider the Bond set after his arrest on multiple Domestic Violence charges. Mover does not deny the serious nature of the charges, but hopes and means to bring to the Court's attention his serious need for mental health treatment, due, in part, to his addiction to alcohol. Confinement due to lack of ability to make the bond will destroy his business and his ability to support his family, which includes his two children and his wife.

MOVER has been in mental health counseling for the past three months, but has been advised he needs more advanced treatment. MOVER has already been accepted at River Place Behavioral Hospital in La Place, Louisiana. Dustin Fields, Administrator at River Place, is Administrator of five different treatment facilities and believes the security at River Place is sufficient to ensure strict attendance and compliance, for as long as is needed for progress and any time limit set by the court. MOVER and his family will bear all costs.

WHEREFORE, MOVER MICHAEL SATCHER, through his attorneys, prays that:

1. This matter be set for hearing as soon as possible;
2. The Bond set and placed on hold be reconsidered and eliminated or reduced;
3. MOVER MICHAEL SATCHER be allowed to attend treatment at River Place facility.
